**ORDER TO SURRENDER FIREARMS**

THE COURT upon consideration of the Respondent’s Sworn Statement of Possession of Firearms filed in this cause, testimony presented in open court, and this Court otherwise being fully advised has hereby ORDERED and ADJUDGED that Respondent, \_\_\_\_\_, is ORDERED to surrender any and all firearms in his/her possession and/or ownership.

**IT IS FURTHER ORDERED:**

1. The Respondent will immediately designate a representative and make necessary arrangements for this individual to surrender all firearms in the Respondent’s care, custody, or control to the law enforcement office identified on this Order Monday – Friday between the hours of 8:00am – 4:00pm.
2. To the individual surrendering the firearms on behalf of the Respondent: **For your own safety unload the firearms and place them in the trunk of the vehicle. Notify personnel of your arrival, and an officer will retrieve the firearm from your vehicle. DO NOT WALK ACROSS THE PARKING LOT OR APPROACH AN ENTRANCE TO THE COMMAND/STATION WITH A FIREARM ON YOUR PERSON.**
3. To the individual surrendering the firearms on behalf of the Respondent:

If you do not have a vehicle with which to take the firearms to law enforcement, you may seek transportation from another party but are prohibited from using public transportation while in possession of firearms.

4. Representative for Respondent will obtain a surrender receipt from the Police Department or Sheriff's Office where firearms were surrendered. This receipt will be necessary in order to reclaim the firearm once the protective order has expired. Law enforcement will notify the Court that the surrender has been accomplished, indicating the Respondent, date of surrender, warrant number and firearms surrendered.
5. The Respondent will be responsible for filing a copy of the surrender receipt with the El Paso District Clerk's Office within 48 hours of the issuance of the Protective Order.
6. When the Protective Order expires the Respondent will have 30 days to file a Motion to Retrieve.

7. Failure by Respondent to present an Order to Return to a local law enforcement agency within 90 days of the expiration of the Protective Order may result in the destruction of surrendered firearms.

This Order will be faxed to the law enforcement substation where firearms will be surrendered.
