

General information for
Filing your Complaint with JP2 Court

When filing a Small Claims & Justice Court Suit. On your complaint form circle the case type you wish to file with our court, cross out the other and initial.

Example: IN THE SMALL CLAIMS ^(initials) ~~JUSTICE COURT~~ OF EL PASO COUNTY, TEXAS
PRECINCT NUMBER TWO

Once you have filled out and complete the complaint form you must sign your complaint in the presence of a Notary Public. If you do not know of a Notary Public then you may sign the complaint in the presence of our Court Clerk.

You need to provide the court with a copy of the complaint for each person named at the top of the complaint form. For example, if you name a Plaintiff and two Defendants you will need the original form and two copies to appropriately file with the Court. If you need a copy for your records you will need a third copy. If you request our office to make copies, you will be charged \$1.00 for the first page and .25¢ for each additional page.

Our Court Clerks are trained in procedure only, and cannot give any legal advice.

Legal advice can only be obtained from an attorney. Should you feel you need legal advice please contact El Paso Bar Association at 532-7052 and/or Legal Aid 585-5100.

Need a certified interpreter?

The Court does not have a court interpreter nor can the court staff interpret for you. If you need an interpreter the day of trial you are responsible to contract the interpreter at your expense.

YOUR CASE MAY BE DISMISSED IF YOU FAIL TO ATTACH
THE SERVICE MEMBERS CIVIL RELIEF ACT (SCRA)

You must obtain and attach to the complaint the Military Status Report.

You can obtain this information at www.epcounty.com Select "Departments" located at the top right corner of the tool bar. Scroll down and select "Justice of the Peace 2." Scroll down to "Forms and Helpful Links" and select Service Members Civil Relief Act (SCRA)(PDF). You must provide the court a Military Status Report for each Defendant. Enter as much information you have. If you do not have the social security number, enter zeros. (see example "A") and select "LookUp." Print your result (see example "B").
